BOARD REPORT

At its September 9th Board meeting the board approved the Branch's 2021-22 budget. The budget is posted on our website and summarized below.

The Board discussed leadership, programming, recruiting and fundraising as we move into a post-Covid world and the need for input from all members – ideas and involvement.

We are excited to get back to in-person meetings - masking is recommended but not required by the Church.

As required by our Policy Guidelines the Board reviewed its policy guidelines. National now only requires that a Administrative Officer (President) and a Financial Officer (Treasurer) need to be elected - other officer positions can be appointed as needed by the Board. We have been discussing how we need to adjust our Policy to clarify the AAUW allowance of 'Appointed' officers as part of the voting board. It now reads:

Per the AAUW Bylaws the Livonia Branch Board voting members are Elected Officers, any appointed officers, Area Interest Chairs and Standing Committee Chairs. Whenever possible, it is recommended that Board members shall not serve more than six consecutive years on the Board of Directors.

Annually the President reports to AAUW an administrative and financial contact for the Branch.'

2022-23 BRANCH BUDGET REPORT

Per our Bylaws, a board approved budget is presented at the September general meeting and is posted on the website. At their September 6th meeting, the Board approved a balanced budget for 2022-23. We have summarized the Board approved budget here. The full budget is available on the website or can be emailed or US Mailed to you for the asking.

The budget projects \$10,840 in income and expenses. We had 92 members eligible to renew; 71 renewed and 1 member who had not renewed in 2022 rejoined us for 2023. Bringing our membership to 72. As you know only \$11 of your AAUW dues stay at the branch. The remaining \$79 is paid by us as dues to National and State AAUW. Your local dues help to pay for our speakers, the Communiqué, meeting room donation, the directory, membership recruiting, other branch operating costs and donations to education and equity mission goals. In no way, does the \$11 paid by each member (\$792 in 2022- 23) cover all branch expenses. Fundraisers are necessary for us to cover operating expenses and also cover Branch donations to our education and equity activities. Last year our budget for these donations was \$6,050. Thanks to our past fundraisers, in particular the auction, and our conservative expenses we have a sufficient reserve and check book balance to allow us to take this year to re-engage our activities, fundraising and recruiting activities. At this point last year, we had \$8,500 in reserve and \$26,106 in the check book; this year we still have the \$8,500 reserve but only \$24,022 in the check book; which suggests that if our membership does not grow, we will continue to spend down the check book balance and need to use the reserve. We need to increase membership and fundraising efforts.

The Board recognizes that covid complicated and still impacts our recruiting and ability to immediately capitalize on new and energized fundraisers. So, again, we budgeted conservatively and will need to draw from our check book balance and "reserve" fund to cover costs. We will use this year to plan new events and we ask members to step up and help us design future replacement fundraising activities.

LIVONIA BRANCH SCHOLARSHIPS at SCHOOLCRAFT COLLEGE

In 2014 our Branch established a scholarship at Schoolcraft College Foundation. Funds are awarded with preference given to a female student who is enrolled in a minimum of 6 credit hours per semester and who is having difficulty financing their education as defined in their scholarship essay. Funds, up to \$500 per semester, are awarded for tuition, fees, lab fees and textbooks. These awards are made by Schoolcraft in compliance with Schoolcraft College Foundation and Schoolcraft College Financial Aid Office procedures and applicable regulations of the State of Michigan and the federal government.

In 2020 our Branch was the recipient of a \$25,000 gift from the estate of long-time member Nancy Sannar. Nancy was a member of AAUW-Livonia Branch for over 35 years. She served in various leadership roles on the Board of Directors and was its president in 1990. The Board established a Committee lead by Treasurer Carol Symanns and including our Scholarship Chair and Education and Equity Co=Chair, Betty Coller, our Ways and Means Chair, Nancy Shaw, several past presidents and long-time members. The Committee proposed a scholarship endowment in Nancy's honor as a thank you for her dedication to the mission of AAUW and the Livonia (MI) Branch. The Nancy Sannar Scholarship Endowment was officially established in early May 2020 using the same preference and procedure for awarding recipients \$500 per semester. The letter establishing this new scholarship and the Memorandum of Understanding between the Branch and the Foundation are filed at Schoolcraft Foundation.

Two scholarships were provided in 2021-22 fall and winter semesters; from the Livonia Branch AAWU Scholarship Fund. Each scholarship was for \$500 and went to Kate Romano. We received a thank you letter from Kate which is included in this Communiqué. The Livonia AAUW Nancy Sannar Endowed Scholarship will provide its first scholarships for the 2022 fall and 2023 winter semesters.

The branch intends to contribute additional dollars to these scholarship as they are available and approved by the Board of Directors. **Individual members may make contributions directly to one or both scholarships at any time**.
