AAUW of Michigan State Dues: \$ 12

- Due date for AAUW of Michigan dues is **July 1, 2023**
- State dues remain unchanged at **\$12.00** per member per year
- **Paid Life Members (MBL)** pay only State and Branch dues
- **Honorary Life Members (MBHL)** pay **NO** dues
- **Regular Student Affiliates (SAF)** dues are \$2.00 per year
- **In-State Dual** Members pay AAUW and state dues through their primary membership branch but are listed on your branch roster totals (no additional AAUW or state dues required from your branch)
- **Out-of-State Dual** Members pay AAUW dues through their primary membership branch, and owe AAUWMI dues through your branch and are listed on your branch roster totals
- **College/University Reps and e-Student affiliates pay NO state dues.** (e-SAF are NOT included in branch or state membership counts)
